
#### **Our Vision Statement**



## Satir Institute of the Pacific Board of Directors Job Description



#### **SIP Board of Director Job Summary:**

The Board of Directors is chosen to manage the Satir Institute of the Pacific, an incorporated non-profit Society in British Columbia and a registered Charity with Revenue Canada. It has the power to act for the Society except where the Articles of Incorporation of the Society say that a decision must be made at a members' meeting. The board must act within all legislated and contractual requirements. It must obey all resolutions passed at members' meetings. The board can only act legally after a decision has been made within an adopted procedure for decision making. The directors must act at all times in the best interests of the Society as a whole, so as to preserve its assets, further its interests, and promote the purposes for which it was formed.

**Reports to:** The Membership

**Source of Authority:** The Board of Directors is elected at the Annual General Meeting by the members of the Society.

**Term of Office:** Directors are elected for three years, with a staggered system of term completion, and cannot sit as a director of the Society for more than three consecutive terms. Following the completion of a director's third term of office, he/she must step down from the Board for a minimum of one year.

**Composition:** The Board of Directors has up to 9 elected directors. If not holding an elected position the following are also ex-officio members of the Board: Past President for a one year term; Director of Training, appointed by the Board; Director of Membership Services, appointed by the Board; Director of Marketing, appointed by the Board. The Board of Directors may number up to 13 directors in total.

**Key Duties and Responsibilities:** I. Attend all Board meetings. 2. Prepare for meetings by reading relevant minutes and reports. 3. Respond to emails requesting decisions or input within 72 hours. 4. Keep in touch with general needs and concerns of all aspects of the Institute's operations. 5. Remain up to date with relevant legislation and policies. 6. Accept responsibility for specific tasks as assigned from time to time. 7. Participate on at least one committee of the Board. 8. Attend the annual retreat.

**Financial Responsibilities:** I. Understanding financial implications of her/his decisions and recommendations to members. 2. Monitors expenses and income. 3. Approve annual budget. 4. Conduct periodic evaluations of the Institute's operations with a view to improvement. 5. Recommend the appointment of an auditor.

#### General Responsibilities of the Board of Directors as a whole include:

1. Promoting the mission and vision of the Institute 2. Ensuring the Institute carries on all its activities within the requirements of all applicable legislation, policy and agreements 3. Developing all Institute policy and ensure all policies and bylaws are either properly enforced or amended 4. Ensuring long-range program planning and financial forecasting is in place 5. Taking responsibility for the overall financial stability of the Institute 6. Ensuring adequate financial controls are in use and that financial records are up-to-date and accurate 7. Ensuring the re-generation of the membership and the Board of Directors 8. Providing guidance to the membership in the selection of energetic, qualified and effective Directors 9. Appointing committees to carry out ongoing operational tasks, procedural functions, and recommendation of policy 10. Hiring competent staff/contractors and audit and support their performance 11. Keeping in touch with the needs and concerns of members, training staff/contractors, volunteers and training participants 12. Reporting regularly to the membership on the activities of the Board and the affairs of the Institute 13. Implementing a system of evaluation of the Institute's activities.





# What Happens When a Client's Defenses Arise in Therapy? By Dr Madeleine De Little

I have had some experience with a colleague who suddenly cutting off all ties with me. This was after a number of discussions, meetings and sharing of vulnerable parts of us. It was not simply just a cutting off but a complete rejection of myself, a rupture without anyway of repair. What I want to share is what I think was going on for both of us to open up a discussion within the Satir community of transference and countertransference, projective identification and enactments.

The term "projective identification" was introduced by Melanie Klein. This phenomena is a primitive defense mechanism (Schore, 2012) influenced by events of the first year of life and is a pre-verbal right-brain to right-brain mode of communicating and relating. Projective identification results in one person in a dyad, projecting a denied part of himself (good or bad) "not so much onto but 'into' another person and ends up by powerfully controlling the receiver from within like a glove puppet" (Rogers, as cited in Molnos, 1998, para 2). In therapy, clients try to project the exact emotions they had experienced with someone else in the past, into the therapist. In effect, at an unconscious level, the client is trying to have the therapist experience the client's unwanted parts of themselves (Klein cited in Schore, 2002) which the client wants to evacuate.

An enactment often follows projective identification and is the moment where the client is connected to their previously hidden, traumatic, disorganized, enduring, defense mechanisms (Schore, 2002). Thus the goal of therapy specifically TST is to help the client find "more mature defensive operations" (Schore, 2002, p. 7).

Much of the recent neuroscience understanding of the development and role of defenses was brilliantly intuited by Satir. Trauma originates in our earliest relationships between mother and child. The resulting conflation of emotions, images and words becomes established in the embodied mind. If there is chronic misattunement in this early relationship, then intense dysregulated affects take over the individual. In order to attempt to regulate these intense emotional states the individual develops dissociative or default defenses. These defenses serve to cut off emotional feelings and bodily sensations as an attempt to regulate them. Satir knew that the defenses serve to protect and care. That is a central tenet of the Satir model: the defenses have a positive intention.

As therapists we have to use our congruent, attuned self to create a safe enough space for the client to titrate their feelings and body sensations into awareness as they concomitantly lower their defensive drawbridge. This allows the client to integrate these sequestered parts of their self and to experience their feelings, their bodily sensations and encounter themselves as whole and complete. The client yearns for genuine connection and the therapist is able to provide that as a bridge to a deep connection to self and others.

For some of our clients they yearn for connection and yet they spurn it. They want to feel safe but are too scared to surrender to the safety net provided by another. This can lead to a depth of confusion for the therapist and client. When you, the therapist ask yourself "what on earth happened in that session" you might want to check out the transference/countertransference between you and the client. The transference/countertransference in the intersubjective relationship has the potential to enact old defensive ways for the client. This is where my story begins. (continued on next page)

# What Happens When a Client's Defenses Arise in Therapy? Con't By Dr Madeleine De Little

Let's call my colleague, Gloria. Gloria is a successful therapist and over the time I knew her, she shared how impressed she was with my work and the writing of my book. As our trust grew between us over the months, we would share what was happening for us. We both wanted to work in metaphors in order to access the parts of us that were quarantined off in our implicit memories and where words of the left brain could not reach. Our times together were profoundly transformative. However, after some months I gradually became aware that she 'wanted' me to experience what she had experienced and at the same time was jealous that I had never experienced the trauma of abuse and dismissal that she had endured as a child. I began to feel beaten up and confused by the intensity and juxtaposition of Gloria's admiration of me and simultaneously her absolute disdain and jealousy of my relative freedom from early traumatic experiences. Through projective identification she subtly and then gradually more overtly, forced her past experiences of disgust and shame into me. I withdrew. This was no longer a safe relationship where I could be vulnerable. She wanted me to be vulnerable. It became clear that she unconsciously wanted me to feel like she felt. As her demands of such vulnerability became louder, I in turn felt less safe to be vulnerable. Unconsciously and paradoxically she set the stage for me to not give her what she had needed when young. As Gloria's projective identification intensified my withdrawal, supported her attachment history. A self -fulfilling prophecy that no one was there for her, nor could she rely on anyone. It was as if my relatively healthy congruence was becoming intolerable for her and she wanted to destroy it. She could not /would not tolerate any repair of such a rupture. She told me quite clearly this breakdown in the initially safe relationship was my fault.

Although my experience was with a colleague, I offer this encounter to the reader, so as to be aware of the intersubjective dynamic between therapist and client. Being a congruent, authentic, healthy and knowledgeable therapist has the potential to enact a client's dissociated protection of a plethora of feelings and body sensations that all appear to be internally working against each other. These parts of self, dominated by defenses of shame, and envy are counterproductive to transformation. Sometimes the eloquent inquiring words of the therapist unintentionally exacerbate the client's defenses.

In order to minimise this possibility, perhaps this points to further discussion around 'intentional mindful silence'. I am not sure about what Satir would have said about the role of a mutual silent space; however, it is my experience that there are times when less words of inquiry assist the client to be safely companioned in their .journey of uncovering and experiencing themselves.

The transference and countertransference that occurs because of projective identification and the enactment of old default ways of keeping safe has the potential to wreak havoc on the therapeutic relationship. It is however the repair of the rupture that is essential to the therapeutic relationship and needs to be addressed immediately. If it isn't then it is likely that you will not see your client again.

## **INTERNATIONAL NEWS**

Jennifer Nagel shared her reflections of one of the groups she just worked with in Hong Kong and Nanjing. An experiential workshop about social trauma in the midst of Hong Kong's social trauma was an intensely rich and deeply moving experience. This group photo was taken literally minutes before evacuating the building due to what was going on all around us.

Here is one participants' learning:

"I have learned from your workshop to believe more firmly that there is a good intention and a function for survival and growth in all the bodily, emotional experiences, even though we might have reactive negative feelings, such as pain, fear, helplessness and anger and negative somatic symptoms. I am now convinced that all of these so labelled negative feelings and symptoms can be utilized to access the positive life energy and the will to live, which are connected to the center of the human Self. The meeting and exchange of these two energy flows need to happen within the whole iceberg (Virginia Satir's metaphor for a human being) at the here and now to bring about change, transformation and healing."







